## Section 2 - Hazards Identification

### Statement of Hazardous Nature

This product is classified as: Hazardous according to the criteria of SWA Australia.

Not a Dangerous Good according to Australian Dangerous Goods (ADG) Code, IATA and IMDG/IMSBC criteria.

**Risk Phrases:** R43, R52/53. May cause sensitisation by skin contact. Harmful to aquatic organisms, may cause long-term adverse effects to the aquatic environment.

**Safety Phrases:** S2, S28, S60, S61. Keep out of reach of children. After contact with skin, wash immediately with plenty of water. This material and its container must be disposed of as hazardous waste. Avoid release to the environment. Refer to special instructions/Safety Data Sheets.

## Emergency Overview

**Physical Description & Colour:** Green gel.

**Odour:** No specific data - expected to be mild, characteristic odour.

**Major Health Hazards:** possible skin sensitiser.

## Potential Health Effects

**Note:** sensitisation to ingredients such as d-limonene occurs in only a small percentage of persons, but those who are sensitised may show severe reactions. Most people may use this product in complete safety, however those sensitised to d-limonene should avoid contact with this product.

### Inhalation

**Short Term Exposure:** Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

**Long Term Exposure:** No data for health effects associated with long term inhalation.

### Skin Contact:

**Short Term Exposure:** Classified as a potential sensitiser by skin contact. Exposure to a skin sensitiser, once sensitisation has occurred, may manifest itself as skin rash or inflammation, and in some individuals this reaction can be severe. In addition product may be mildly irritating, but is unlikely to cause anything more than mild discomfort which should disappear once contact ceases.

**Long Term Exposure:** No data for health effects associated with long term skin exposure.

### Eye Contact:

**Short Term Exposure:** Exposure via eyes is considered to be unlikely. This product is believed to be mildly irritating, to eyes, but is unlikely to cause anything more than mild transient discomfort.

**Long Term Exposure:** No data for health effects associated with long term eye exposure.

### Ingestion:

**Short Term Exposure:** Significant oral exposure is considered to be unlikely. However, this product is believed to be mildly irritating to mucous membranes but is unlikely to cause anything more than mild transient discomfort.

**Long Term Exposure:** No data for health effects associated with long term ingestion.

### Carcinogen Status:

**SWA:** No significant ingredient is classified as carcinogenic by SWA.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## Section 4 - First Aid Measures

### General Information:

## Section 6 - Accidental Release Measures

---

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. All skin areas should be covered. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective goggles.
